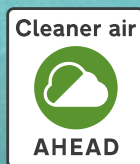


A Clean Air Zone for Bradford

The Clean Air Zone

The Clean Air Zone (CAZ) will include the Outer Ring Road and into the city centre, including Manningham Lane, Canal Road and Shipley/Saltaire. Keighley, Ilkley and Bingley are not included in the CAZ because levels of pollution are lower in these areas. Roadside cameras will record vehicle movements in the CAZ area.

A 'Class C' CAZ means that drivers and operators of the following vehicles will be charged to enter or drive within the zone if they have a non-compliant vehicle. This is a vehicle which does not meet the latest emissions standard.

Certain vehicles, such as emergency vehicles and breakdown trucks, will be exempted.

Additional financial measures, incentives and exemptions are offered, including **grants** towards vehicle upgrades, support for **electric taxis** and local **exemptions**.

Poor Air Quality

Bradford is one of several local authorities directed by the Government to bring levels of air pollution within legal limits in the shortest possible time. Long-term exposure to air pollution can cause chronic conditions such as cardiovascular and respiratory diseases including lung cancer, leading to reduced life expectancy.

In Bradford, air pollution is linked to around 200 preventable deaths each year and causes the ill-health of other residents in the district - particularly those with respiratory conditions. One in five Bradford children already have a breathing problem.

A Clean Air Zone

The Council is introducing a Clean Air Zone (CAZ) as part of its Air Quality Plan. Daily charges will start to apply to certain higher polluting vehicles in **Spring 2022**.

Further details of the exact launch date will be released on the Clean Air Zone website.

Clean Air Zones are now operating in London, Birmingham and Bath and are planned to start in Sheffield, Manchester, Portsmouth and Tyneside in the coming months.
