Subject Matter	Burley Parish Council has produced a proposed Neighbourhood Development Plan which covers the Burley Parish Council boundary. The Plan contains a vision for Burley along with a set of objectives, planning policies and proposals to achieve the vision. The planning policies within the Plan seek to protect the character of Burley with policies guiding new development, including housing, Burley local centre, employment opportunities, as well as protection policies relating to local greenspaces, views and allotments.

Consultation period	Written comments are invited during the 6 week consultation period commencing on Monday 12 <sup>th</sup> June and concluding at 5pm on Monday 24 <sup>th</sup> July 2017.

## **PUBLICATION**

Under Regulation 15 of the Neighbourhood Planning (General) Regulations 2012, Burley Parish Council has submitted its proposed Neighbourhood Development Plan (NDP) to the City of Bradford Metropolitan District Council.

In accordance with Regulation 16, Bradford Council will publish the Burley-in-Wharfedale Neighbourhood Development Plan, Proposals Map, Basic Conditions Statement, Statement of Consultation, Strategic Environmental Assessment & Habitats Regulations Assessment and an Equality Impact Assessment for comment on Monday 12<sup>th</sup> June 2017. Comments are invited and encouraged on the Comment Form provided.

Representations must be received by 5pm on Monday 24<sup>th</sup> July 2017 via the methods outlined above.

**Group Responses** - Where there are groups who share a common view on how they wish to see the Plan changed, it would be very helpful for that group to submit a single representation which represents the view of the group, rather than separate individual representations which repeat the same points. In such cases the group should indicate how many people it is representing and how the representation has been authorised.
