HIGHWAYS ACT 1980

THE CITY OF BRADFORD METROPOLITAN DISTRICT COUNCIL (A650 HARD INGS ROAD IMPROVEMENT, KEIGHLEY) (SIDE ROADS) ORDER 2017

The City of Bradford Metropolitan District Council make this Order in exercise of their powers under sections 14 and 125 of the Highways Act 1980 and all other powers enabling them in that behalf :-

1. (1) The Council are authorised in relation to the Classified Road at Keighley in the City of Bradford to :-
 - (a) improve the length of highway named in the Schedule to this Order and shown on the Site Plan by cross hatching;
 - (b) stop up each private means of access to premises described in the Schedule and shown on the Site Plan by a solid black band; and
 - (e) provide new private means of access to premises along each route or at each location shown on the Site Plan by thin diagonal hatching.

(2) Where a new access is to be provided in connection with the stopping up of a length of private means of access described in the Schedule, its reference number is placed in the Schedule opposite the description of that length.

(3) The Site Plan shows the works indicated in the Schedule and the route of the Classified Road in relation to those works.

2. In this Order:

(1) all measurements of distance are measured along the route of the relevant highway or private means of access to premises, as the case may be;

(2)

(i) "the Classified Road"

means the A650 Hard Ings Road which the Council propose to improve from its junction with the A629 Beechcliffe Roundabout, generally eastwards to a point 75 metres west of its junction with the Bradford Road Roundabout, and which is a highway which has been classified by the Secretary of State for Transport as a principal road for purposes of enactments and instruments which refer to highways classified as principal roads and which is a highway which is a classified road in accordance with section 12 of the Highways Act 1980;

(ii) "the Council"

means the City of Bradford Metropolitan District Council;

(iii) "improvement"

in relation to a highway includes raising, lowering or otherwise altering that highway, and "improved" shall be construed accordingly;

(iv) "new access"

means a means of access to premises authorised by this Order to be provided;

(v) "the Site Plan"

means the Site Plan contained, along with a Location Plan, in the plan folio marked "The City of Bradford Metropolitan District Council (A650 Hard Ings Road Improvement, Keighley) (Side Roads) Order 2017", sealed with the Common Seal of the Council and deposited at the offices of the Council at City Hall, Centenary Square, Bradford BD1 1HY; a duplicate has been deposited at the offices of the Secretary of State for Transport.

THE SCHEDULE

Westerly access from the A650 Hard Ings Road to the Texaco Filling Station (and integral catering and retail services) and Vehicle Washing facilities (marked X2 on the plan).

PA2

Easterly access from the A650 Hard Ings Road to the Texaco Filling Station (and integral catering and retail services) and Vehicle Washing facilities (marked X3 on the plan).

PA3

Access from the A650 Hard Ings Road to the Keighley Cougars Rugby Ground (marked X4 on the plan).

PA4

Westerly access from the A650 Hard Ings Road to the Hard Ings Motor Company (marked X5 on the plan).

PA5

Easterly access from the A650 Hard Ings Road to the Hard Ings Motor Company (marked X6 on the plan).

PA6

Access from the A650 Hard Ings Road to the premises of Aire Valley Decorating Centre Limited, Bargain Tyres, City Plumbing Supplies Holdings Limited, Elite Customs, Viking Industrial Products Limited and Unit 386 of the Sea Cadet Corps, all located at the Coronation Business Centre and to premises of Keighley Cougars Rugby Ground (Keighley Cougars (2010) Limited) and United Carpets Property Limited (marked X7 on the plan).

PA7

Access from the A650 Hard Ings Road to the premises of United Carpets (marked X8 on the plan).

PA7

Access from the A650 Hard Ings Road to Fibreline Limited, Victoria Park Mills (marked X9 on the plan).

PA8

Pedestrian Access from the A650 Hard Ings Road to Fibreline Limited, Victoria Park Mills (marked X10 on the plan).

PA9

Access from the A650 Hard Ings Road to the Keighley Ambulance Station (marked X11 on the plan).

PA10

Access from the A650 Hard Ings Road to the Hard Ings Road Allotment Gardens (marked X12 on the plan).

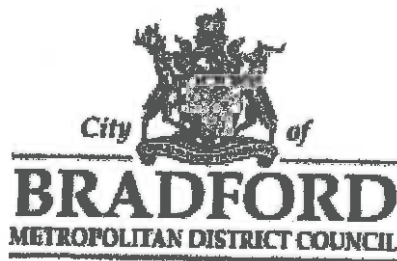

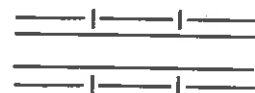
