In paragraph 5.10, the Inspector considers that there are exceptional circumstances to release the extension land from the Green Belt, and include it in the Harrogate Road employment site.</p> <p>The Council accepts that the extension land should be removed from the Green Belt, and designated as employment land, but does not agree in full with all the reasoning contained in paragraph 5.10. The Council accepts that exceptional circumstances need to be demonstrated for land to be removed from the Green Belt, however, a review of the Green Belt in itself cannot be considered as an exceptional circumstance. The Council does, however accept that decisions elsewhere in the plan which have led to the loss of employment land and the need to provide for replacement employment land in a strategic and accessible location are exceptional circumstances, which can justify such Green Belt deletions.
