Section 5.1 Fig EC1, combined with sections 5.3.31, 5.7.20 and 5.7.22 clearly shows the tactic of releasing green belt area within the Baildon location (to attain the 450 new homes). The most obvious site being the green belt between the recent Heritage View development (Baildon Reservoir, off West Lane) and Dene Hill. The World Heritage Site at Saltaire experiences broad views of upper Baildon and Baildon moor. World Heritage status is maintained by keeping these views as experienced when World Heritage Status was attained by Saltaire. Heritage View although only recently completed was granted planning permission prior to the World Heritage Status being granted to Saltaire, hence the reason for the continuation of the development at that site. Although, I understand there were some grave concerns by the World Heritage Organisation. Development of this green belt would almost certainly jeopardise the World Heritage Status, which according to the DPD is 'one of the jewels in Bradford's crown'. World Heritage Status brings much needed finance (tourism, businesses, etc) and prestige to the region. Therefore maintaining this status should be a priority to Bradford City Council and should be outlined in the DPD.
