Whilst Bradford Council notes the A65 and Wheatley Lane are already at capacity the plan would lead to further traffic on these routes with no adequate provision for this.

It has not taken account of the specific nature of Ilkley and its heritage status.

It does not comply with the government's green belt policy framework.

Adequate use of current brown field sites is not made within the plan.
