Infrastructure and Sustainability

The Plan recognises that the capacity of existing infrastructure, particularly transport and education, is a major concern across the District, and that all options for the location of new development would result in significant additional pressures.

Addingham is approximately 17 miles from the major centres of Bradford and Leeds, and lies at the most extreme geographical part of the Bradford District. The village, as one of the Plan's Local Service Centres, is amongst the least sustainable locations for growth in the District (para 5.3.64). Notwithstanding the Plan's proposals for local needs housing only in the village, the infrastructure position reinforces the view that new housing on anything other than a very limited scale, and phased over the plan period, would have major impacts on the already congested transport network particularly the A65, as well as school provision.

Other parts of Wharfedale, even settlements with stations, are also suffering major levels of congestion on both road and rail, and development on the scale proposed in Wharfedale would increase pressures unacceptably.

Unless the Plan proposes programmed and funded infrastructure improvements, particularly transport and education, to be delivered in line with new housing, development levels in the outer parts of the District such as Wharfedale should be scaled back considerably.
