I am objecting to the core strategy development plan compiled by Bradford Council, and their proposals for Holme Wood urban extension.

I do not believe that the plan complies with the 'duty to cooperate' with adjoining local planning authorities. In this case, specifically with Leeds council.

There appears to be no evidence of consultation processes that demonstrate how, and with whom, Bradford council have 'cooperated'.

The proposed extension boundaries with Leeds and is in close proximity to my home in the Bankhouse area of Pudsey. My neighbours and I are dismayed by these proposals, which will adversely affect the greenbelt area in which we live.

We rely on our local (Leeds) councillors to represent our views during liaisons with their Bradford counterparts. Our voices cannot be heard when Bradford council have not complied with this duty in any committed or consistent way.

I do not think it is acceptable that, at this late stage, the process of cooperation is not demonstrated or transparent. I therefore believe that Bradford council have failed in their duty to cooperate.
