We note with amazement that unlike almost all the other policy statements in the Core Strategy there are no Indicators or Targets for the above Policy, just a very vague and imprecise statement of anticipated Outcomes on page 93.

Without targets there is nothing to monitor against and so the aspirations for Wharfedale remain woolly, insubstantial and meaningless. There are no firm guidelines for example on how the transport policy objectives will be met and nothing in the Policy on Education or how the capacity will be increased to meet the demands of the target housing growth. 4.3.3. for example, whilst recognising the direct rail services to both Leeds and Bradford ignores the fact that the line is now under severe strain at peak times and has reached the limit of line capacity, train length and entry slots into Leeds station. The matter would be further aggravated dependent upon the proposed link with Leeds/Bradford Airport. The necessary infrastructure improvements needed now and even more so with housing growth seem to be a wish list with no serious well considered plan to deliver.

It could be convincingly argued that as drafted the Policy WD1 is a series of worthless promises with no conviction of delivery.
