We note, with concern, that protecting farmland, particularly in the categories 1 > 3, is not referred to in Paragraph D of this critical Sub Policy. Menston and Burley are surrounded not only by Green Belt land but also category 3 farmland used for cattle and sheep grazing. This is a serious omission as this land, which has important agricultural value, is not clearly distinguished from the marginal land characteristic of much of Bradford for development purposes. Account needs to be taken to the closeness and impact of the South Pennine Moors Special Area of Conservation (SAC).
