Over the years there have been many developments in Ilkley without consideration for extra provision of public transport, medical facilities and schools, not to mention the extra strain on the Victorian drainage system which supports the Ilkley area.

The main arterial routes into and out of Ilkley are already at full capacity with long delays regularly experienced in both directions. Parking is already a problem in the town with commuters parking further and further away from the station. There is nowhere to provide for the extra volume of cars on main routes, side roads and parking.

Local schools are full to capacity as witnessed by the fact that Ashlands Primary School has just been extended to cope with current local numbers.

At commuter times, the trains to and from Ilkley are already full beyond capacity with many passengers standing for most of their journey. It is not possible to add extra carriages to these trains because of the length of the platforms on the route.
