The strategy is unsound as it does not comply with the NPPF on preserving the green belt or with the European Directive on natural habitats, rather it conflicts with these Paras, 28,37,80,81,82 of NPPF. The geographical topography of the town does not allow house building on steep slopes or on the flat valley bottom that is prone to flooding because of myriad water courses that come down off the moor. This means that the railway embankment is unstable and prone to ringslip problems. A change in the nature of the environment would have a negative impact on the character of the town for visitors and tourists as well as residents.
