This can be provided within individual homes or on a development-wide basis and there should be an onus on the applicant to justify why a 30% target cannot be achieved.

Please note your representation should cover succinctly all the information, evidence and supporting information necessary to support/justify the representation and the suggested change, as there will not normally be a subsequent opportunity to make further representations based on the original representation at publication stage. Please be as precise as possible.
