We consider the plan to fail on the duty to cooperate as the provision of these dwelling on Green Belt land is in contravention of the entire reasoning behind the establishment of Green Belt in the first place and that some of the proposals have been opposed by neighbouring authorities (in the case of Holme Wood extension) and by parish and town councils within the Bradford District.
