- 4.1 This plan is in conflict with National Planning Policy for protecting green belt land.
- 4.2 This plan does not provide for the additional primary and secondary education places that would be needed. Nor does it indicate or suggest where the resource for creating additional school places and teaching staff would come from. The same lack of provision applies to GP services and to rail services. This plan ignores the impact of additional vehicle traffic on the A65 and other roads such as Valley Drive, Ben Rhydding Road, Clifton Road and Bolling Road. It also ignores the already overcrowded car parking facilities.
- 4.3 The proposals leading to this plan have been poorly communicated to those who would be affected by a significant increase in demand for overstretched services as listed above. This Representation Form uses language which some might find difficult to understand and it demands a response with more technical content than an average person is accustomed to providing. Therefore it may act as a deterrent to some who would otherwise respond.
