The study referred to in this paragraph and throughout the document is the Open Space, Sport and Recreation Study dated 2006. The baseline data has not been updated to reflect current demand and supply of outdoor sports provision so is considered to be out of date and not robust. In relation to the evidence base to identify the needs and opportunities for sport and recreation there is no currently adopted Playing Pitch Strategy, Outdoor Sport Strategy or Indoor Sports Strategy. The reasoned justification seems to infer that the assessment of need referred to in policy EN1 is the 2006 Study. However, the identification of deficits, surpluses and open space standards are very much out of date. The Playing Pitch Strategy which will replace the outdoor sports element of the 2006 Study will be finalised and adopted before the Core Strategy is adopted. Sport England would like to see reference to the 2006 Study and the Open Space Standards in Appendix 9 removed from the reasoned justification to avoid confusion. During the Core Strategy's lifespan the evidence base will continually be updated and the action plan and standards associated with the evidence base will change. If standards are explicitly set out in the Core Strategy they will become out of date very quickly. Sport England would strongly suggest referring to standards and actions contained within an up to date evidence base.

Sport England is involved in the preparation of the Council's emerging Playing Pitch Strategy. An Assessment Report has been prepared and the Strategy Report is underway at the time of writing. However, the findings of the Assessment have not been used to help inform the relevant policies and open space standards contained within this plan.

Sport England is a statutory consultee on all planning applications that affect playing fields and in addition are often consulted in an advisory capacity on planning applications that affect or create new sports provision. Sport England Playing Fields Policy and the criteria contained within paragraph 74 of NPPF are used to assess these applications. The first criterion of both Sport England policy and paragraph 74 of NPPF relate to the loss of playing field/sports facilities that are clearly shown to be surplus requirements. An up to date and robust Needs Assessment in accordance with paragraph 73 of NPPF is used to identify whether the playing field/sports facility is surplus to requirement or should be replaced. Paragraph 73 clearly states planning policies should be based on robust and up to date assessments of needs and opportunities. It is Sport England's opinion that policies based on out of date data could:

- undermine Sport England's statutory remit; and

- lead to inappropriate provision of sports facilities based on out of date standards

Sport England consider inappropriate and out of date evidence has been used to justify sport and recreation related policies (EN1) and the open space standards set out in the appendix 9. It is considered the lack of up to date and robust evidence of needs and opportunities is contrary to paragraph 73 of NPPF.

Sport England would like to see reference to the 2006 Open Space Sport and Recreation Study and the Open Space Standards in Appendix 9 removed from the reasoned justification to avoid confusion.

During the Core Strategy's lifespan the evidence base will continually be updated and the action plan and standards associated with the evidence base will change, especially for pitch sports, on an annual basis. If standards are explicitly set out in the Core Strategy they will become out of date very quickly. Sport England would strongly suggest making reference to standards and actions contained within an up to date evidence base rather than referring to a specific dated study/strategy that will become out of date during the lifespan of the Core Strategy. This will ensure applicants reference the most up to date evidence base rather than an out of date evidence base.
