This policy refers to “*delivering the most houses possible while taking into account - nature of the site, its surroundings and given the type and size of housing needed in the area*”. This is all in the context of a minimum of 30 dwellings per hectare.

Both Burley and Menston have a wide range of densities within their boundaries. In some areas a much higher density level is appropriate and have been successfully achieved.

However other parts of the villages currently have very low density and new significantly higher density developments would sit very uncomfortably within these.

Para A needs strengthening to allow new development perhaps at a significantly lower density than 30 houses per hectare providing it provides the highest possible density while still appropriate to their surroundings.
