Soundness - Sustainability - Jobs

Consistent with national policy: the Core Strategy Development Plan should enable the delivery of sustainable development in accordance with the policies in the National Planning Policy Framework.

The Plan pays almost no regard to the available employment opportunities. Ilkley is primarily a tourist destination with most jobs in the hospitality and retail sector.

There is very little industry in the town, and even administrative jobs are not common, as witnessed by the office building at Dansk Way which is now virtually unoccupied, and the nearby industrial units which have been empty since construction last year.

New residents will therefore have to commute into Leeds and Bradford, notwithstanding existing congestion on the main A65, struggling transport links and lack of parking in the town centre.
