Section 4 Sub-Area Policies

This response has been produced by CPRE West Yorkshire on behalf of the Yorkshire Greenspace Alliance (YGA). Owing to the short timetable for the consultation and the level of detail required to comment meaningfully on the sub-area policies, it has not been possible for us to incorporate sub-area responses into our core response, although we anticipate that a number of the local groups who are members of YGA will be making sub-area responses.

We do hope to be considered for participation in sub-area sessions at the Public Examination, in collaboration with local YGA members, and so at this stage we wish to raise a broad concern about the sub-area policies.

It is impossible to assess from the policies exactly which areas of greenfield and Green Belt land in each sub-area would be likely to be affected by the policies. Clearly we may refer to the SHLAA as evidence of sites that *might* be developed, but since we are informed by the Council that the sites for the Holme Wood urban extension have not yet been identified, there appears to be no direct relationship between site availability through the SHLAA and strategic intention as expressed in policy. Without being able to make this connection it is not realistic to assess the degree to which the sub-area policies are positively prepared in pursuit of sustainable development, or effective in having suitable sites with which to implement spatial objectives.
