I cannot accept that Ilkley is a justified "principal town" because it is on the edge of the city, has a very small proportion of the overall population of Bradford and is not an employment centre as the majority of its adult population is either retired or commutes to work elsewhere in the hinterland. The local infrastructure (e.g. roads, schools, transport facilities) is already stretched to a limit, and unable to deal with the population increase which would result from this proposal.

As a result, the proposed volume of 800 houses is excessive for the area and would require an excessive use of allocated green belt land to produce this volume of housing. I understand that the Government supports the Green Belt Policy, but to provide the suggested number of houses some 55% would have to be built on land already shown as Green Belt in the Ilkley area.

I regard the Core Strategy to be unsound in regard to justifying its principal town status and indicated number of projected houses.
