I strongly object to the proposal to allow the building of 800 additional dwellings in likley; I believe this is unsustainable and will negatively impact the economy of likley and will result in a marked deterioration of the quality of life for likley residents. Further, it does not satisfy national guidelines or even those within the Core Strategy itself. My reasons for stating this are as follows:

(Section 4.3, Figure WD1, Spatial Vision Diagram) – This states the vision to 'Enhance the heritage value of towns... along Wharfedale corridor', however the planned new homes threaten likley's heritage value and tourism and leisure interests:

- 1. The economy of Ilkley is based on its role as a centre for visitors. This means that the general town 'look and feel' and surrounding scenery are an integral factor in the continued economic success of the town. It needs to retain the characteristics of a small spa town. The addition of 800 houses would strongly negatively impact this. The preservation of the Green Belt around Ilkley is not a luxury, it is a necessity in order to preserve the character of, and view from, the town and therefore its economic base. The town and its surrounds will lose its unique nature, its separateness and overall attractiveness.
- 2. The effect of building on the approved sites would be to promote ribbon development along the A65 corridor. The A65 approach from the East would be dominated by new housing in the area to the South above the road.

### (Section 3, para 15.3 - importance of sufficient infrastructure to support the plan)

- 3. There is no strategy proposed to build up the infrastructure of the town and surrounding area the schools, hospitals, roads and drainage systems needed for the addition of 800 houses. According to UK government statistics, this would correspond to a population increase of at least 1,850 people with at least 955 cars.
- 4. There would be a demand for between 350 and 650 school places; however all the schools in the town are full.
  - Bradford District Education Organisation Plan shows that primary schools in the Wharfe valley are presently over-subscribed and will continue to be so until 2017 which is as far as the Education Plan goes.
  - ii. The need to increase the capacity of ilkley Grammar School has long been recognised by the council, and in fact an earlier earmarked site in Ben Rhydding is now a potential site for new homes
  - iii. The extra demand will surely lead to schooling solutions outside the Wharfedale catchment area with extra car/bus usage and attendant impacts on environment.

#### (Section 3, para 6, policy SC4)

5. Ilkley has been designated a "principal town" alongside Keighley and Bingley, yet

- i. Its population is less than 3% of the Bradford District total
- ii. It is one-third the size of Keighley
- iii. It is not an employment centre, more of a commuter centre
- iv. It sits on the edge of the District
- v. Most council services have been removed, there are no hospital or emergency medical facilities, and bus services to Bradford have been curtailed.

#### (Section 3, paras 103-116, policy SC8)

- 6. More than 25% of the District's new homes will be built on green belt and for likley this will be at least 55%, yet the National Planning Policy Framework says that
  - i. "the government attaches great importance to green belts" (para 79)
  - ii. four of the specific purposes are "to prevent towns merging into one another; to assist in safeguarding the countryside from encroachment; to preserve the setting and special character of historic towns and; to assist in urban regeneration by encouraging the recycling of dereild and other urban land" (para 80)
  - ifi. "once established, green belt boundaries should only be altered in exceptional circumstances" (para 83)

For all these reasons, I strongly urge the Council to reduce the number of additional houses to a much smaller figure corresponding to genuine infill and the use of brownfield sites.
