I do not believe the plan for Wharfedale is sound as:

- It is not positively prepared as it does not match development with infrastructure requirements (particularly education and transport) and is therefore not consistent with achieving sustainable development.
- It is not consistent with the National Planning policy Framework.

The plan is to build 1600 homes in Wharfedale, 800 of which in Ilkley with little plan to increase school places other than monitor the live birth rate (per the Local Infrastructure Plan (LIP). The LIP states that the school places position in Wharfedale is already classed as CRITICAL. It has been critical for a number of years even before any proposed development begins. The LIP states that given the existing profile it is likely that builders will want to build family homes rather than other types. So the already critical position will become untenable. The LIP also says that shortage of school places could pose significant challenge to delivery of growth' para 5.5.1.

So the current form of the plan means that it is not consistent with sustainable development

- Economically as it is not ensuring that sufficient land of the right type is available in the right place at the right time.
- Economically as it does not co-ordinate the planned housing development with the required infrastructure eg schools
- Socially as it does not meet the needs of th present generation let alone the future inhabitant with accessible local services.

So what will the Council do with all the children unable to access school places –possibly allocate them out of area schools? This will increase congestion on the only route through the area the A65 which is already congested at peak times. Given the geography of the steep narrow valley, river and town it is not clear to see how improvements could be made. The only other route out to the rest of the district is over the moor road which is narrow and windy. Indeed the LIP does not include road infrastructure improvements either.

A further fact is that the land previously earmarked for a new increased capacity secondary school has now been earmarked for more housing! How can this be considered joined up co-ordinated planning! The site of th old middle school is also in the process of being used for housing! The Council have an

existing school places problem but instead of solving it are aggravating it.
The site of the existing school is not amenable to extension. It is on a steep slope. There are no playing fields on site – all 1500 pupils have to be bussed (along the A65) to the playing fields. There is insufficient space to allow all year groups to eat on site. Due to the limited space post 16 access is restricted to those achieving more than 5B grades at GCSE.
Also the land the Council is proposing to build on is green belt land which again suggests the plan for Wharfedale is not positively prepared as it fails on the 3 <sup>rd</sup> dimension of sustainable development per the National Planning Policy Framework- that of protecting and enhancing the natural environment. The Framework states that the government attaches great importance to Green Belt. Given the practical infrastructure issues noted above re education and transport which the LIP fails to address I do not see why the Council is justified in building on the green belt in Wharfedale per its Core Strategy – the Council has not made a coherent case for declassifying Green Belt in this case.
