5.5.2 Education

'The provision of school places in the Wharfedale sub area is a critical infrastructure issues. There is an existing capacity issue in Wharfedale, due to its popularity as a family location and loss of BSF funding for Ilkley Grammar School.'

All primary and secondary schools are at or over capacity and that is since the recent expansion of Ashlands Primary and what small modifications have been possible at Ilkley Grammar. None of the schools are able to expand further.

Friends living less than half a mile away from Ben Rhydding Primary, who are in primary catchment, have been allocated a school place at Askwith and having to carry out the school journey using their own transport and to their own cost.
