6.2 Development Frameworks

6.21 Bradford Council is currently producing a Development Framework (DF) for the city of Bradford, Keighley (and Ilkley), and Shipley (and Bingley). The work is being led by CBRE and the commission started in September 2022. The intention of the DFs are to set the direction, development principles and some specific site based opportunities to deliver sustainable economic growth, shape where the Council focuses investment and priorities for regeneration over the next 20 years, working alongside the public, private and third sector. The DFs will generate investment confidence and will also maximise development potential beyond Bradford 2025, the Towns Fund



and Levelling Up, to create work opportunities that improve lives and protect the environment for future generations.

6.22 The frameworks cover all aspects of place and will provide an illustrative vision of what a place could look like in consideration of specific opportunities for development, showcases how they might look alongside what would be required to make those developments happen. Outside of the city of Bradford framework the work has focused on Keighley and Shipley as areas with the greatest opportunity for regeneration.

6.23 The visioning and stakeholder engagement stage has recently been completed and a draft development framework is due to be ready Summer 2023 and subsequently consulted on with focus groups. The initial work undertaken includes baseline review of existing documentation (such as the Airedale Masterplan, and stakeholder consultation, which has included Town Deal Board Chairs for both Keighley and Shipley.

6.3 Towns Fund (TF) Performance Template – to 31st March 2023.

6.31 Deadline for submission to DLUHC is Friday 9th June 2023 for the reporting period 1st October 2022 – 31st March 2023.

6.32 DLUHC ran two workshops (Wednesday 17th May & Wednesday 24th May) to provide additional guidance to projects regarding the TF Performance Template. Council Officers attended both workshops.

7. PR & Communications

7.1 PR

7.11 Further to the discussion held on the 22nd March 2023 with Marketing and Communications colleagues, the team are working well with Regeneration to develop press releases. The Regeneration Team are developing a forward planner to line up press releases across the Towns Fund programme to ensure timely and systematic release of positive news stories for each town.

7.12 A meeting was held with Keighley Town Council on 15/05/23 with agreement in principle to enhance existing marketing and PR activities. This includes pages on the Towns Fund on the new Keighley Town Council website.

7.13 Outline costs have been agreed with an SLA being drawn up to ensure risks, communication and PR activities are coordinated in line with Bradford Council and Towns Fund objectives. Regular meetings also suggested with the Town Council, which will be put in place once the SLA has been agreed. Currently awaiting a response from Keighley Town Councils on the SLA and will update the Board accordingly.



7.14 A business Case for a new website has been submitted to Bradford Council IT services for redevelopment of the existing Towns Fund pages on the council website. The current website can be viewed at ourtownkeighley.co.uk **Appendix 3** contains the existing websites (ourtownshipley.co.uk and ourtownkeighley.co.uk) alongside the proposed changes which have been accepted.

7.2 Communications

Background

7.21 Improvements in communication between the Board, Council Officers and Projects have been an area of concern highlighted at previous board meetings for both Keighley and Shipley.

7.22 To partially address this, Council Officers will publish all the minutes of Board Meetings on the Bradford Council Website when approved. The links to these will be sent to all Board Members as well as the all Councillors in the Towns Fund area.

7.23 Project updates will also be provided at each Board Meeting which will include a financial summary to provide members with an overview of each project, its progress and risks. In some cases, project sponsors maybe invited to present a case to the board that provides an update for information or decision.

Current Position

7.24 Board meeting minutes have been published and shared to Board Members and Councillors to reflect the discussions and agreed actions of the Towns Fund.

7.25 Meetings with Town Councillors for Keighley and Shipley scheduled until February 2024 to provide updates on the Towns Fund to Councillors on each project and progress to date. This will



also provide an opportunity for open and transparent communications between Council Officers managing the Towns Fund and local Councillors.

7.26 A concern is around projects that are putting out press releases or signage without the guidance of the Towns Fund team or running this by Marketing to ensure compliance, comments or feedback prior to publication. As such, a process map put together for press releases / publications and shared with Project Sponsors, to ensure collaboration and appropriate messaging when promoting Towns Fund Projects. This includes guidance from DLUHC and Bradford Council regarding appropriate signage and checks before press releases are issued.

7.27 Forward Plan (**Appendix 2**) put together for Marketing to review which projects will require press releases and are planned in advance. This will be shared with the Town Councils as well as discussed with Project Sponsors at Monthly Meetings to factor in any PR that will be released.

Item 7 – Press Release on Keighley Health and Wellbeing Centre



Keighley gets green light for health and wellbeing centre

Keighley has today (2 June - TBC) received Government confirmation of the funding it needs to proceed with building a new health and wellbeing centre.

The funding of £3.4million forms part of a Towns Fund grant from the Department for Levelling Up, Housing and Communities (DLUHC).

It means that building the centre can now get underway with the centre expected to open in the summer of 2026.

The new facility would include GP services, self-care and prevention, community care, mental health, dental care, a GP training hub and other healthcare services, at an accessible town centre location.

The scheme would also bring around 200 jobs to the town centre, 50 of them being new posts, helping bring extra footfall to local shops and other businesses.

The site on which the new centre will be built comprises two areas of brownfield land at the corner of North Street and Cavendish Street, previously occupied by Keighley College, which was demolished in 2017.

Ian Hayfield, Keighley Towns Fund Chair, said: "It is fantastic news for Keighley that we've been given the go-ahead by the Government for the Health and Wellbeing Centre. It is a project



that will make a real difference and bring in much needed investment to help achieve real social and economic change for our community."

"I want to thank all the residents and businesses of Keighley, the project sponsors, my fellow board members and the council for the hard work that has gone in over the last few years."

Professor Mel Pickup, place-based lead for Bradford District and Craven Health and Care Partnership, said:

"The funding announcement is great news for the people of Keighley and for our whole health and care partnership. The new Health and Wellbeing Centre is much needed and will provide a 'state of the art' integrated health and wellbeing centre at the heart of Keighley. The centre will bring a wide range of services under one roof, and help ensure local people receive the care they need closer to home. This project is an exciting opportunity to construct a landmark building on the central site that enhances the town centre, provides value for money and, most importantly, improves the health and wellbeing of local people."

Clir Alex Ross-Shaw, Portfolio Holder for Regeneration, Planning and Transport, said: "The announcement today is a great result for Keighley. It will bring a brand new facility in the heart of Keighley, in easy reach of transport links and which will provide essential services to improve the lives of those living in the community.

"In addition it will be a great boost for investment and jobs for Keighley and the wider district. This is a partnership success and thanks must go to the Keighley towns fund board and everyone involved in this bid who has made this happen."
