Notes and Definitions

Oversubscribed School – If a school was oversubscribed this means there were not enough places for all applicants who required a place, and the relevant school's oversubscription criteria needed to be used to determine who the available places were allocated to.

Undersubscribed School – If a school was undersubscribed this means there were enough places for all applicants who required a place, and there were surplus places remaining. Some of these surplus places may have been allocated to children who did not qualify for a place at any of their preferred schools.

Oversubscription Criteria – A school's oversubscription criteria forms part of their Admissions Policy, and it outlines how places will be allocated if there are more applicants requiring places than places available.

Admissions Policy – These contain, amongst other things, a school's oversubscription criteria. They can be viewed on the relevant school's website and also on www.bradford.gov.uk/admissions.

Criterion – A category of a school's oversubscription criteria. The wording of the final criterion under which a child was allocated at a particular school in the table above has been shortened for simplicity. Please see the relevant policy for full wording.

Fair Banding – If a school uses fair banding, children need to sit an assessment for the school. Their results are used to put them into an ability band and the school allocates a certain number/proportion of students from each band. If a child has not sat the assessment, they will only be considered for a place if all children who sat the assessment have qualified for a place and there are places remaining.
